THIS IS A RELEASE OF LIABILITY – PLEASE READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the program, related events and activities, I the undersigned, acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of injury does exist.

2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, known and unknown. **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES** of others, and assume full responsibility for my participation.

3. I willingly agree to comply with the terms and conditions for participation. If I observe any unusual or significant hazard during my participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.

I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, **HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE DIAMONDHEAD RESORT**, its officers, officials, agents, and/or employees, other participants, sponsors, advertisers, and, if applicable, owners and lessors or premises used to conduct the event (RELEASES), from any and all claims, demands losses, and liability arising out of or related to **ANY INJURY, DISABILITY OR DEATH** I may suffer, or loss or damage to person or property, **WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASES OR OTHERWISE**, to the fullest extent permitted by law.
